The last day to register by mail or online and be eligible to vote in the November 5, 2024 General Election is **MONDAY, OCTOBER 21, 2024**. MCL 168.497

After this date, anyone who qualifies as an elector may register to vote in person with proof of residency (MCL 168.497) at the Township Hall Clerk's Office located at 21131 Gardenlane, 202, Ferndale, MI 48220-Room 202.

Regular business hours: Monday-Thursday from 9:00 a.m. – 4:00 p.m.

Saturday, November 2, 2024 hours: 8:00 a.m. – 4:00 p.m.

Election Day, November 5, 2024 - 7:00 a.m. – 8:00 p.m.

Sample Ballot can be viewed in the Clerk's Office. Information can also be viewed under the Secretary of State Michigan Voters Information Center (MVIC).

The deadline for mailing absentee ballots is Friday, November 1, 2024, at 4:00 p.m. For mailing, a written request must be submitted to spoil ballot to reissue by mail is also Friday, November 1, 2024, at 4:00 p.m. **All spoiled ballots are reissued by written request only.**
